After the Warranty Period, you must pay for all labor charges.

In addition, RSD will supply, at no charge, new or rebuilt replacements in exchange for defective parts for a period of one (1) year. After one (1) year from the date of purchase, labor for removal and installation is available from RSD authorized dealer at your expense.

To obtain warranty service, please contact RSD to obtain a Return Merchandise Authorization number (RMA) and shipping instructions. Product must be shipped freight prepaid, in either its original packaging or packaging affording an equal degree of protection. RSD will not receive product without an RMA and is not responsible for loss or damage incurred in shipping to RSD.

This warranty does not cover customer instruction, installation, set up adjustments, or other problems.

This warranty does not cover cosmetic damage or damage due to acts of God, accident, misuse, abuse, negligence, commercial use, or modification of, or to any part of the Product.
